2. The School is required to apply on online for further extension of affiliation along with the requisite documents as per Rule 10.3 of Affiliation Bye Laws.
3. The school will also abide by the conditions prescribed, if any, by the State Government concern in certificate as per appendix III issued by District Education Officer (DEO) /equivalent officer.
4. The school should ensure the strong governance and management of its activities in way of cor quantifiable planning in way of curriculum planning, infrastructure, resources, physical development and other co-curricular areas.
5. The school should go through the provision of **Affiliation and Examination Bye Laws and ke of** for reference purpose and also advised to visit CBSE websites i.e. <http://cbseac> <http://cbse.nic.in/> for updates. The School is expected to see all circulars on these CBSE website
6. The school will strictly adhere to all rules regarding safety of students including Fire fighting an etc. Further, school will provide adequate facilities for potable drinking water and clean heat toilets with washing facilities for boys and girls separately in proportion to the number of students
7. **Admission to the school** is to be restricted as per relevant rules of Examination Bye-laws and 7.1, 7.2, 8.4.2, 8.4.10 & other relevant rules of Affiliation bye laws.

14. Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class examinations from the year mentioned while granting affiliation/upgradation regularly without bre reasons thereof in writing well in time about the non-sponsoring of the candidates.
15. Running of **coaching institutions** in the school premises in the pretext of providing coaching to various examinations is not permitted by the Board. Strict action would be taken on defaulters.
16. The Manager and the Principal of the school shall be jointly responsible for the authenticity of documents/ information/data submitted by the School to the Board.
